We shall briefly examine some conflicts between religion and science in history, recently, and possible conflict in future.

i. Galileo Galilei's Affair

Throughout history, moments of conflict between science and religion have arisen when scientific discoveries challenged established religious doctrines or authority. Perhaps the most famous example is the Galileo affair, in which Galileo Galilei's support for the heliocentric model of the solar system clashed with the geocentric cosmology endorsed by the Catholic Church. Galileo's advocacy for heliocentrism indeed led to significant conflict with the religious authorities of his time, particularly the Catholic Church. At the heart of the matter was the clash between empirical evidence, as demonstrated by Galileo's observations through his telescope, and the entrenched religious views of the Church.

Galileo's support for heliocentrism challenged the prevailing geocentric model endorsed by the Catholic Church, which held that Earth was at the center of the universe. This challenge was not merely scientific but also theological, as it directly contradicted certain interpretations of Scripture that placed Earth at the center of God's creation, for one example, as the Holy Bible mentions an hierarchy of heights like heaven, earth, and under the earth in Revelation 5:3. Galileo's ideas were seen as a challenge to the authority of the Church, which

not only had significant power over matters of faith but also held sway over many aspects of society, including education and science—before science gained independence through its own progress and advancements. The Church was not entirely antagonistic against science but part of the ingredients which made the conflict spicy was Galileo's decision to publish his ideas in a popular dialogue format, rather than a purely scientific treatise, which further exacerbated tensions. In this work, he presented arguments for heliocentrism in a manner that some interpreted as mocking the Aristotelian worldview supported by the Church.

Again, church generally, whether the Catholics denomination or others, is not an enemy of progress and there was more to this conflict than the seeming battle for supremacy in the authority of understanding. The fact that Galileo's confrontational style and his criticism of church leaders, particularly Pope Urban VIII, was a reality, worsened his situation. His failure to win the support of key figures within the Church hierarchy left him vulnerable to attack. Also, the timing of Galileo's advocacy for heliocentrism was also significant. In church history in a number of seminaries, records hold the understanding that in the early 17th century, Europe was still reeling from the effects of the Protestant Reformation. The Catholic Church was particularly sensitive to any challenges to its authority, fearing that they could undermine its efforts to maintain unity and control.

In 1616, the Catholic Church's Congregation of the Index issued a decree condemning the heliocentric theory, declaring it "formally heretical" and banning any works that supported it. Galileo was warned not to advocate heliocentrism as fact, but rather present it only as a hypothesis.

Galileo's continued support for heliocentrism despite these warnings eventually led to his trial by the Roman Inquisition in 1633. He was charged with heresy for violating the 1616 decree and was forced to recant his views under threat of torture. He spent the rest of his life under house arrest.

This conflict between Galileo and the Catholic Church is often cited as a prime example of the tension between empirical evidence and religious authority hinged upon spiritual revelation, highlighting the challenges of reconciling scientific discovery with deeply held religious beliefs.

Although, relationship has greatly improved between religion and science but it is not enough and I hope that by this book, additional voice can be added to a more respectful relationship between the duo and each recognizing their strengths and weaknesses in our exploration of understanding and truth.

ii. Scopes Monkey Trial

Similarly, the Scopes Monkey Trial of 1925 brought to light the conflict between evolution and biblical literalism in American society. The trial, which pitted the teaching of evolution against the biblical account of creation, captured the broader cultural divide between scientific progressivism and religious conservatism in the United States.

In the early 20th century, several states, including Tennessee, passed laws known as "anti-evolution" statutes, which prohibited the teaching of evolution in public schools. The Butler Act, enacted in Tennessee in 1925, made it unlawful to teach "any theory that denies the story of the Divine Creation of man as taught in the Bible." Then, came John T. Scopes, a high school science teacher in Dayton, Tennessee, who deliberately violated the Butler Act by teaching evolution in his classroom. His actions were part of a coordinated effort by the American Civil Liberties Union (ACLU) to challenge the constitutionality of the law. Scopes was arrested and charged with violating the Butler Act. This led to a legal battle that attracted widespread attention, with prominent lawyers Clarence Darrow and William Jennings Bryan representing opposing sides. Darrow, a renowned defense attorney, argued in favor of evolution and against the Butler Act, while Bryan, a three-time Democratic presidential candidate and a staunch advocate of biblical literalism, argued for the prosecution.

The trial became a public spectacle as Darrow and Bryan engaged in heated debates over the validity of evolution and the literal interpretation of the Bible. Darrow called Bryan to the witness stand as an expert on the Bible, questioning him on his literal interpretation of biblical stories such as the Creation account in Genesis. The trial received extensive media coverage, including radio broadcasts and newspaper reports, which brought the debate over evolution and biblical literalism to a national audience. The trial was seen as a symbolic clash between modern science and traditional religious beliefs. Scopes was found guilty of violating the Butler Act and fined \$100,

although the verdict was later overturned on a technicality. Despite the legal outcome, the trial raised awareness of the tension between science and religion in American society and sparked ongoing debates over the teaching of evolution in public schools.

iii. The COVID19 Saga

These implants have the potential to revolutionize various aspects of human life, from seamless access control and payment systems to personalized health monitoring and identification verification.
